



Proof of US Residency Options for Dependents Living in the US **(when the dependent does not have a passport with a date of entry stamp)**

Dependents under 6 years old:

- **US medical record**, that must:
 - Be a shot/immunization record that has the dates of the child's medical history and care; the most recent date must be within the last 12 months
 - Contain the child's name, date of birth, and address
 - Contain the name, address, and phone number of the doctor, hospital, or clinic where treatment was received
 - If this information is not printed on the medical record, you must also get a letter that has this information on official letterhead from the Federal authority, physician, hospital, or clinic that treated the child. The letter must be dated within the last 12 months and must be signed by the doctor or clinic official.
- **US school record**, that must:
 - Be for a school term no older than 12 months from the date of the W-7
 - Be an official report card or transcript issued by the school or equivalent of a Ministry of Education
 - Contain the student's name, date of birth, and address
 - List the student's classes and grades in those classes
 - Have the date of the grading period(s)
 - List the school name and address
 - Be dated and signed by a school official
- **US visa**, that must:
 - Be issued by USCIS
 - Be unexpired, original, and legible
 - Contain the applicant's name. The name on the bank statement must match the name on the W-7 application and on the applicant's original ID documents.
- **US state identification card**, that must:
 - Be issued by a US state agency
 - Be unexpired, original and legible
 - Contain the applicant's name. The name on the bank statement must match the name on the W-7 application and on the applicant's original ID documents.
 - Contain the applicant's address in the US
 - Contain the applicant's signature (if a signature is required by the state or agency that issues the document)

Dependents under 18 years old:

- **US school record**, that must:

- Be for a school term no older than 12 months from the date of the W-7
- Be an official report card or transcript issued by the school or equivalent of a Ministry of Education
- Contain the student's name, date of birth, and address
- List the student's classes and grades in those classes
- Have the date of the grading period(s)
- List the school name and address
- Be dated and signed by a school official
- **US visa**, that must:
 - Be issued by USCIS
 - Be unexpired, original, and legible
 - Contain the applicant's name. The name on the bank statement must match the name on the W-7 application and on the applicant's original ID documents.
- **US state identification card or driver's license**, that must:
 - Be issued by a US state agency
 - Be unexpired, original and legible
 - Contain the applicant's name. The name on the bank statement must match the name on the W-7 application and on the applicant's original ID documents.
 - Contain the applicant's address in the US
 - Contain the applicant's signature (if a signature is required by the state or agency that issues the document)

Dependents aged 18 and older:

- **US school record**, that must:
 - Be for a school term no older than 12 months from the date of the W-7
 - Be an official report card or transcript issued by the school or equivalent of a Ministry of Education
 - Contain the student's name, date of birth, and address
 - List the student's classes and grades in those classes
 - Have the date of the grading period(s)
 - List the school name and address
 - Be dated and signed by a school official
- **Bank Statement**, that must:
 - Contain the applicant's name. The name on the bank statement must match the name on the W-7 application and on the applicant's original ID documents.
 - Contain the applicant's address in the US
 - Be dated within the last 12 months
 - Be original, not a copy - *must include a signature from a bank representative*
- **Utility bill**, that must:
 - Contain the applicant's name. The name on the bank statement must match the name on the W-7 application and on the applicant's original ID documents.
 - Contain the applicant's address in the US
 - Be dated within the last 12 months
 - Be original, not a copy
- **Rental statement**, which must:

- Contain the applicant's name. The name on the bank statement must match the name on the W-7 application and on the applicant's original ID documents.
- Contain the applicant's address in the US
- Be dated within the last 12 months
- Be original, not a copy
- **US visa**, that must:
 - Be issued by USCIS
 - Be unexpired, original, and legible
 - Contain the applicant's name. The name on the bank statement must match the name on the W-7 application and on the applicant's original ID documents.
