## Redacted SSN on ITIN Holder's W-2: What Can and Should We Do?

## **Background**

Beginning in 2020 in order to protect employees from identity theft, the IRS began to permit employers to voluntarily redact (or hide) employees' Social Security Numbers (SSNs) on employee copies of **Forms W-2**, *Wage and Tax Statement*. No redaction is permitted to employer or other EINs, or of SSNs on Employer Filings to Tax Authorities.

Redacted SSNs are formatted as xxx-xx-1234 or \*\*\*-\*\*-1234.

In order to e-file a tax return prepared from a **Form W-2** that contains a redacted SSN, the complete and accurate SSN must be entered in TaxSlayer. This information can usually be verified from the taxpayer's SS card or other tax documents. Once the complete SSN is entered, the return can be e-filed as usual.

## **How to Assist the Taxpayer**

If an ITIN holder presents **Form W-2** that contains a redacted TIN in **Box a** that is not the taxpayer's ITIN and is not an SSN issued to the taxpayer, the full SSN must be identified and entered in TaxSlayer in order to e-file the return.
